# **Annual Meeting Minutes Review:**

- Jim read the minutes from our 2021 Annual Meeting to the homeowners.
  - There was a motion from the floor to accept the minutes with minor corrections.
  - o There was a second from the floor.
  - Unanimous approval from the homeowners.

## 2021 Major Projects:

- Parking lot sealcoating
  - o Discussion:
    - The sealcoat project was not fully completed at the time of the 2022 Annual Meeting, therefore, we did not pay for the entire project.
- Carport repairs
- Storage door replacements

## 2022 Major Projects:

- Deck repairs
- Storage door replacements
  - o Discussion:
    - We want to replace storage doors for units that need it
    - This is an expensive project, so we break it up over time
    - Our goal is 10 doors a year

## 2022 Budget Talk:

- Dues Increase:
  - Our last dues increase was in 2015.
    - Our expenses have increased 15% since that time.

- o Water Damage has greatly contributed to our overall expenses annually.
  - In 2021~ we saw laundry lines break, water heaters leak, faulty tub drains.
    - There have been suggestions of water alarms
    - It was suggested we send letters to homeowners about water heater replacements.
- o There is a 3% suggested dues increase and special assessment of \$40,000.
  - Two-Bedroom Rates:
    - Dues increase of \$11/month
    - Quarterly assessment of \$120.20
  - Three-Bedroom Rates:
    - Dues increase of \$14/month
    - Quarterly assessment of \$143.32
  - This decision was not taken lightly.
  - Copies of the draft budget were mailed to the homeowners.
- Vote to REJECT the budget
  - o No one voted to reject the budget
  - The budget was unanimously approved.

#### **Board Member Voting:**

- Sheila Arestad's term ended
  - Sheila offered to step down from her position.
  - $\circ\quad$  Debra Kraft ran for the open board position.
  - o Debra was elected with 41 votes.
- Patricia Albert's term ended
  - Patricia re-ran for election.
  - o Andrea Wilmot also ran.
  - o Andrea was elected 18 − 9
