 - The spa has a leak.
 - Trees, bushes, and stumps were discussed and added to the agenda as items.
 - There is no scheduled meeting in April.

Linsey's Manager Report:

- Here are highlights:
 - The reserve study has been completed and can be found online.

Matters Requiring Board Discussion & Voting:

- No Trespassing Sign:
 - We have a 12x12 mock-up of the sign.
 - \circ The board requested the sign size increase to 16x16.
- Spa Leak:
 - There is a spa leak.
 - We have scheduled a meeting with the plumber next week.
 - The board discussed replacing the spa entirely.
 - The board will discuss spa options once we have more bids.
- Stumps:
 - The bid came back for stump grinding: \$1100.
 - The board approved this bid unanimously.
- Madrona Tree @ Building 02:
 - We do not have a bid for the removal of this tree.
 - \circ $\;$ The board has requested a bid for this.
- Madrona Tree @ Building 03:
 - The board has decided to explore alternative options for the sidewalks at Building 03 that do not require the tree to be removed.
 - The board made a motion to keep the madrona tree.
 - This motion was approved.
- Tree Trimming:
 - This project has been deferred until Spring.
- Sidewalk Concrete
 - The board currently has 1 bid for sidewalk improvements.
 - There are 2 bids coming in the next week.
 - The board is also examining alternative processes for improving the sidewalks.

The next monthly Board Meeting is scheduled for April 26, 2022.
