#### **Maintenance Committee Report:**

  - o The board decided to purchase a new flag in the Spring.
- Sidewalk Grinding
  - The sidewalk grinders were on property and missed some spots. They need to come back and finish the project.

- Pruning Concerns
  - o There is a tree growing into another at Building 03.
  - o The board will look into having it pruned in the Spring.
- Cable TV Inquiry
  - o A resident asked if our Xfinity Cable cables work for DirecTv.
    - There is an agreement for them to use the same cable.

#### **Linsey's Manager Report:**

- Linsey was very busy.
  - Water issues are still a commonplace occurrence; they take both money and time.
- Many owner's are in the re-fi process right now.
